

CLINTON COUNTY EARLY SETTLER & EARLY FAMILY CERTIFICATE

Clinton County, Michigan is celebrating the 166th anniversary of its organization in 1839. In honor of that occasion, the Genealogists of the Clinton County Historical Society are proud to offer two distinctive commemorative certificates to eligible persons.

ELIGIBILITY: To qualify for a CLINTON COUNTY EARLY SETTLER CERTIFICATE, the applicant must directly descend from an ancestor [male or female] who settled in Clinton County prior to 31 December 1865. To qualify for a CLINTON COUNTY EARLY FAMILY CERTIFICATE, the direct descent must be from a family who resided in Clinton County prior to 31 December 1899. The applicant must be able to prove descent from the ancestor by official or approved records for each generation, including proof for applicant. Current residency in Clinton County is not required. There is a non-refundable fee of \$15.00 for each application.

INSTRUCTIONS:

If you have more than one qualifying ancestor, you must complete each application separately. Only one name will be inscribed on each certificate. All information on charts must be typed or clearly printed in black ink, each page submitted must have your name and the name of ancestor printed on the back.

Each page of proofs must have your name, ancestor name & number of generation on the back.

Write all dates as 3 May1950 NOT as 5/3/50 to prevent confusion. If exact date is unknown, write c1880, if date or month unknown, leave blank or cMay etc.

Use only maiden names for the female lines.

Do NOT send original documents as any information submitted becomes the property of the Archives of the Clinton County Historical Society and cannot be returned..

If you do not wish to correspond with anyone about this family, clearly print NO CORRESPONDENCE on top right of lineage chart page.

Each application must be accompanied by the non-refundable \$15.00 fee. Checks to be made out to the Genealogists of the Clinton County Historical Society.

If brothers/sisters/children/grandchildren of the applicant wish a certificate on this same line and apply in the same packet, on a separate sheet, with proof of relationship to the main applicant, the fee is only \$7.50.

PROOFS: Each proof should be the result of credible genealogical research. Acceptable **PRIMARY** sources are: vital records [birth/marriage/death], land, court, tax, military, church, cemetery, and miscellaneous county records and federal/state/county census. The following **SECONDARY** sources may or may not be acceptable: Bible records [must have copy of title page with publication date], obituaries & newspaper articles [must include name of paper, date published & page], clear photos of tombstones [must have name/location of cemetery & tombstone therein], local histories, state pioneer records, city & county directories, private papers etc. **NOT ACCEPTABLE:** LDS Familysearch or other internet records.

PROOF OF RESIDENCY PRIOR TO 1866: Acceptable proofs are: Land records, various county records, census records.
